We are pleased with your interest in the Reduced Cost Psychotherapy Consultation Service. After you complete this application, you will be referred to a consultant who is a faculty supervisor at WCSPP. Most referrals are made within three weeks, and we will make every effort to meet your interests as indicated on the attached application. The procedures of the service are as follows:

- (1) An application fee of \$50 must be submitted with the application. The fee for ongoing consultation will be \$75 per visit.
- (2) Scheduling will be arranged between you and your assigned consultant.
- (3) Consultants will not be responsible for insurance coverage, reports, or licensure requirements. Applicants must provide their own clinical work for discussion. Participation in this service may not be used to fulfill the requirements of educational programs at WCSPP or elsewhere. Participants may not represent themselves as trainees of WCSPP or any of its programs.
- (4) If a satisfactory arrangement cannot be reached with your assigned consultant, you may return to the Service for a second referral.
- (5) If you continue with a consultant, the arrangement shall remain in effect for up to 40 visits. At the end of that time, you may negotiate a new arrangement with your consultant or you may apply to the Service for a new referral

For this application to be processed, you must submit documentation of your current license and proof of malpractice insurance.

It is understood that in signing this application that you are agreeing to the terms and policies stated above.
